Effective: September 8, 2022



Purpose

Lakeview Academy will meet or exceed all Utah State Board of Education credit requirements. Lakeview Academy will offer electives while keeping the core requirements intact. Electives should emphasize Science, The Arts, and Technology to remain consistent with our Charter. Lakeview Academy will provide at least one foreign language. The school will integrate educational technology and library media into subject areas.

Policy

Credits from an accredited institution will be included on a Lakeview Academy transcript, noting all credit origins, and be "included" as credit requirements on the transcript.

Lakeview Academy Administration shall designate a panel of at least three individuals to review any credits previously awarded at a non-accredited institution. The panel will look at correspondence/online coursework, demonstrated competency, assessment, or review of student work portfolio to ensure that the coursework complies with section 53G-6-204 before including it on the transcript.

Students in grades 7-8 shall earn a minimum of 14 credits.
