Rick Veasey introduced School LAND trust committee membership. Rick explained the LAND Trust. Board members need to go to the website and do the training. USBE land trust (JL send out links). It is land that makes money and the money is invested and then it is distributed to schools. We consistently have spent it in similar ways from year to year. Because the board is made up mostly of parents it can serve as the LAND Trust committee. I am non the committee but I do not vote. The money spent should go to our students and goals. The money is now tied to the TSSP expenditures and reading and math scores. Success is measured through reading and math scores.

Lindsay Condie made a motion to approve the school LAND Trust committee membership for 2022-2023.

Rene moved to amend the motion to exclude Tyler Shimakonis from the school LAND trust committee.

Rene spoke to his amendment that since it is Utah LAND trust funds it should be voted on by those who live in Utah. Joylin Lincoln responded that it will be difficult to keep track of who votes.

Rick Veasey read code 53 G-7-1205. It states that the board or a committee. The code did not have provision for excluding a board member if the two-parent ratio was not met.

Joylin Lincoln respond with 53 G-7-1203? That if there is a committee that the board would still approve the committee work.

Lindsey Condie did not accept the amendment to her motion.
