2. Financial Accountability Committee:

- Financial statement from prior Month Rich Eccles and Tyler Partridge Finance committee met 08/09. Conflict of interest policy sent out today. Required every year. Any conflict of interest needs to be stated on the form. If a conflict exists they would recuse themselves from a vote pertaining to the conflict. Certify that the board has taken the open meetings training. 10 minute video, every 2 years. Who has done, Amy Lusby– yes, Tyler Partridgeno, Ryan Taylor yes, KristiAnn Asarian yes, Erin Merryweather yes, Kenzi Bennion no.
- July financial statement not much cash on hand. Lower because expenses for this upcoming year are higher. Financial statements for the end of year (June) are currently being audited. Board hires auditors to make sure Rich and Jamie are doing their job. Discussion of Jamie and Rich salary to be conducted in a closed session. Legislature set aside money for extra assignments from December to May. Limited funds and each school had to apply with the state in order to receive funds.

3. Construction:

- Report on arena buildout Got plans and got them approved. Out to bid and they came in about 30% higher than expected. \$1.3M after removing everything we can remove.
- Schedule Construction company is ready to begin as soon as we sign the contract, but we will not sign until we have the funds.
- Construction fundraising efforts Soldier Hollow contacted us to sell water and sell merchandise at sheepdog, postcards. David in contact with Wasatch Community Foundation is responding to him; they have been busy so it is moving slow. Fritz B. Burns Foundation is a possible contributor for another \$1M. Jamie has some connections who does fundraising that will be helping us. Karl Malone as a possible contributor because of everything he does in the valley. Phase 2 won't start until end of this school year. \$300k \$900k to complete phase 1.
- 4. Facilities and Transportation updates: Mike Bronson we are ready to go on everything. Old bus is gone. The people that bought it also bought other things that are still in the arena, those items are still here, we need to get rid of that stuff now. Sunday night another window was broken, don't know who did it. Is it ok for the kids to be playing wall ball against the building (structurally)? Look into building something free standing instead. Do we need to get the arena windows fixed? Maybe Plexiglas over it?

Septic system – something was growing. At the very end tank that is supposed to be clean water there is a fungus or mold growing that is going to be pumped out. Thinking that may be the source of elevated nitrogen. Permit has expired and we need to get another one.

- Academic Excellence Early Learning Plan has been approved by the state. Specific to k-3, 2nd grade literacy goals BOY, state wanted an improvement of 8%, Math 21% computation set by the state
- Enrollment 2022/23 340 students enrolled
- Teachers start 8/10 full staff. Lost 1 speech tech. 100% teacher retention. Restructured counseling position. Hire % time counselor and % behavior specialist (BCBA). Social emotional learning into class time daily.
