#### OUR FOUNDING BOARD OF DIRECTORS



Ricardo Mireles is the Executive Director and Founder of Academia Avance, an independent college preparatory public charter school in the Northeast Los Angeles neighborhood of Highland Park that serves over 400 students in grades 6-12. The Avance college attainment outcomes for its graduates tops 80% enrolling in college, the majority at four year institutions, with a 70% persistence rate. Ricardo is a graduate of Columbia College, studied at the MIT Department of Urban Studies and Planning, and taught at the UCLA School of Public Policy and Social Research and at the Don Bosco Technical Institute.

Dianne Jacobson has been the Operations Manager at Skyview School in Prescott, Arizona since 2006. Previously she has served on charter governing boards and worked countless hours supporting charter education as a parent and volunteer. Although she always understood the academic and social benefits charters provided children, at Skyview she became aware of a deeper truth—that the "whole child" approach to education can be brilliantly explored within the autonomy of charter school design, particularly when curricula and methods are developed by educators and parents.





Iris Maria Chávez is an education advocate and public affairs consultant, currently working with national and Oregon-focused organizations to advance equity by supporting the creation of sound, just policies that better communities in Oregon and across the nation. Iris Maria came to the Pacific Northwest from Washington, D.C., where she worked for over a decade in education policy and advocacy for civil rights and advocacy organizations such as the Education Trust and the League of United Latin American Citizens (LULAC). Iris Maria's volunteer work also focuses on community engagement and equity, she currently serves on the Partnership for Safety & Justice Board of Directors and the City Club of Portland Board of Governors.

Richard Lee is the Executive Director of Academy of the City Charter School in Woodside, NY, a school that is as diverse as the Borough of Queens. Previously, Richard was the Division Coordinator for seven years for grades 1-4 at The Bank Street School for Children. Richard has organized, led and presented in various workshop including NYSAIS, DOE and NAIS. Most of these have been about Children of Color affinity groups and Social Studies curriculum. Richard is Asian-American and feels strongly about the presence of administrators who reflect the community that they serve.





David Lockett is a STEM teacher at Bok Academy in Lake Wales, FL and an NSTA Aerospace Advisory Board Member. At Bok Academy, he is responsible for implementing a project-based curriculum for all students as they rotate through the STEM Lab. David has a distinguished and diverse background in the fields of Astronomy, Biotechnology, and Engineering, and is an advocate and practitioner of S.T.E.M. accessibility for all students. David has participated in a variety of NSF projects throughout North and South America, including the Astronomy in Chile's Ambassadors Educator Program and Innovators Developing Accessible Tools for Astronomy.

Christopher Norwood is the Founder of the Florida Association of Independent Public Schools and the Governance Institute for School Accountability (GISA). Christopher is the former Executive Director of Lawyers for Children (Florida), and is certified by the Florida Commissioner for Education to provide Governance Training to Charter Schools. He is sought out by many to represent charter schools with application appeals, terminations and non-renewals before Florida's Administrative Law Judges and School Board Administrative Hearings. Christopher chairs the City of Miami Education Advisory Board and serves on the Audit and Budget Committee of Miami-Dade Public Schools.





Heather Vuncannon is the President and CEO of Innovative Community Schools & Services, LLC in Asheboro, North Carolina. Heather co-founded and led Uwharrie Charter Academy, a rural, independent charter school focused on STE3AM (Entrepreneurship, Environment, and Engineering) and Project-based learning. Heather earned her Master's in Curriculum and Instruction from the University of North Carolina at Greensboro and later her school administration degree from High Point University. She led Uwharrie Charter Academy from its opening in 2013 until recently when she struck out on her own to provide consulting and financial services to charter schools across the state of North Carolina.



Thier philosophy is grounded in both the Native American tradition and a rigorous, modern approach to college-preparatory education. Students of all backgrounds are welcome at NACA.

Kara Bobroff has been working in education for nearly 30 years, beginning her career as a special education teacher. In January 2019, she was appointed by Governor Michelle Lujan Grisham to be the Deputy Secretary of Identity, Equity and Transformation. She was the Founder and Executive Director of the Native American Community Academy Inspired Schools Network in Albuquerque and previously served on President Barack Obama's Advisory Council for Faith-Based and Neighborhood Partnerships. Ms. Bobroff holds a bachelor's and a master's degree in special education, and an educational specialist degree from the University of New Mexico.



Steven Zimmerman has founded two charter schools in Queens and is the founding director of CPICS. He was an elementary school teacher in the inner-city of Chicago during the Model Cities Program years and later worked for 15 years in educational publishing, first as a science editor and later as a developer of ESL, bilingual and design services for US school publishers. Steve has also done a stint in an educational technology startup. He has spent the last several years trying to figure out how to reconcile the polarized sides in the public education dialogue.

# SESSIONS WITH DEBORAH MEJERAndrias



The Coalition of Public Independent Charter Schools is honored to welcome back Deborah Meier, to the Independent Charter School Symposium. Deborah was the keynote speaker at our inaugural event and we're thrilled that she's returning for a more intimate experience.

Deborah will be hosting two exclusive sessions with attendees during our symposium. Each session will offer a limited number of seats so that each attendee has the opportunity to interact with our greatest living exponent of the American progressive education tradition.

Deborah Meier has been working in public education as a teacher, principal, writer, advocate since the early 1960s, and ranks among the most acclaimed leaders of the school reform movement in the U.S. In 1987 she received a MacArthur "genius" Award for her work in public education.

The work that Debbie did at Central Park East in the 1970's and 80's and at Mission Hill in the Roxbury section of Boston in the 1990's was the inspiration for many of us. It is in the DNA of those who envisioned chartered schools as places of teacher empowerment and workplace democracy.

Debbie will be joined by colleague Jane Andrias for two sessions:

#### Session 1: Teachers as Leaders and Agents of Change

Date: Monday, November 18, 2019

Time: 2:30pm-4:00pm

There is a tension between the larger public good and the individual's good. In this session, we will ask: How do classrooms, schools and the school community deal and work with this tension?

### Session 2: Schools and Democracy - Choice, Responsibility, Agency and Democracy

Date: Tuesday, November 19, 2019

Time: 2:00pm-3:30pm

If societal democracy may require schools to be democratic institutions, what do we need to do and when and how do we start to make our schools democracies. In this session, we will ask: How do we as teachers exercise our responsibility to grow and sustain such a school?

#### **ABOUT JANE ANDRIAS**

Jane Andrias began teaching in New York City public schools in 1969. She founded the art program at Central Park East I Elementary School and Central Park East Secondary School and was the director and then principal of the elementary school until 2003. Since her retirement from the NYC public school system, she has served as an adjunct professor at Long Island University, teaching graduate courses in Teacher Inquiry and supervising student teachers.

She has been involved in the design and implementation of an alternative assessment project with several NYC progressive public elementary schools, and she founded and directed the Long Island University Teacher Resource Center. Through her affiliation with The Elementary Teachers Network at the Center for Literacy Studies of Lehman College, she has been teaching a course to public school teachers from several public schools in NYC. She also has been collaborating with Deborah Meier to address the crisis in early childhood and elementary school education.

Jane Andrias is President of the Board of Directors of PerDev. She graduated from CCNY, received a Masters degree from NYU, studied at the Froebel Institute of London University and has been a longtime participant of the Prospect Institutes on Descriptive Inquiry and Practice.

#### What's wrong - and right - with charter schools

Since the early years of charter schooling, Greg Richmond has worked with passionate people across the country to improve quality educational opportunities for children by strengthening charter school authorizing. He first started authorizing charter schools in 1996 when he worked for the Chicago Public Schools where he was inspired by the educators who were proposing new schools. In 2000, he founded the National Association of Charter School Authorizers, served as its first board chair until 2005, and then as its full-time CEO. While he has testified repeatedly before Congress, met with Secretaries of Education, been interviewed by countless reporters from coast to coast, and partnered with major foundations, nothing brings him more happiness or inspiration than visiting with educators and students in their schools.

Greg holds a B.S. in geography from the University of Wisconsin and a master's degree in public policy from the University of Minnesota. Greg is married to his high school sweetheart, Janelle. They met when they were each cast in the leading roles in the school musical, South Pacific.



#### Who Counts? The Urgency of Using Our Schools to Ensure an Accurate 2020 Census and the Consequences if We Fail

Dr. Nancy López is associate professor of sociology at the University of New Mexico. She directs and co-founded the Institute for the Study of "Race" & Social Justice. 


#### LAURIE INMAN





In time students come to realize that education is 24/7, and that they really can be in control of the what and where of it. We will also explore other aspects of our approach to building strong, positive relationships with students at MeANS. Participants will learn innovative strategies from our experience working with vulnerable student populations that may be applicable to their own programs.

Emanuel Pariser co-founded the Maine Academy of Natural Science at Good Will Hinckley in 2010, where he currently consults at Threshold, the School's program for pregnant, parenting and socially anxious students. Emanuel received his PhD in education and psychology from the University of Maine, Orono.

Rebecca Dennison is Dean of the Threshold program at Maine Academy of Natural Science. She earned a bachelor's degree in Psychology from the University of Maine at Farmington and a master's degree in Social Work from the University of New England.

All our teachers attend and contribute in twice weekly staff meetings. All our teachers actively seek ways to enhance their instruction through additional projects. How do we retain such an amazing staff? We do it by staying focused on what those who are dedicated teachers want to focus on: student learning.

Mathew McClenahan has taught at a Catholic school in NYC, in a large comprehensive high school in LA and at High Tech LA, a small charter school in Van Nuys, since the school opened in 2004. A 2005 Milken Educator Award winner, Mat is committed to making teaching and learning the focus of our schools.

#### Mindtraps and Burnout! Effective and practical strategies to manage the stressors of school

Mindtraps catch us all. Trying to juggle multiple demands and cope with the pressures of the job, there are times when we are not at our best. We may feel overwhelmed or we may simply lose energy. At these times, our Mindtraps (or limiting beliefs) make us less effective and prevent us from bouncing back. Building on both trauma-informed practice and growth mindset work, the Mindtraps model helps you recognize how you respond to stress and teaches you a process to help yourself become more resilient, preventing burnout in yourself as well as in staff and students.

Tara O'Brien has worked for nearly two decades in K-12 schools as a teacher, teacher leader, and Principal. She has earned double Masters degrees in Educational Leadership and Curriculum & Instruction. 





- The work we do at our schools is for the greater good. We guard against any practice that subordinates the work we do to personal or corporate profit.

- We seek out opportunities to learn from and exchange ideas with our colleagues.
