# Bridge Elementary Technology Distance and/or Blended Learning Procedures for 2020 – 2021 Updated June 16, 2020

Please see update protocols based on the Required School Re-Opening Plan. The Protocols address distance learning at Bridge Elementary. Approved by the Board and sent to USBE on July 21, 2020. Bridge Elementary will follow all state and local requirements regarding student and staff safety using Utah's color-coded Health Guidance System. Bridge Elementary will implement specific guidelines as provided by the Weber County Health Department, the Utah State Health Department, the State Board of Education and the Utah Governor's Office.

The items noted in YELLOW are the pieces of our Technology Plan for Distance and Blended Learning.

### **RED HIGH RISK**

- School building is closed to students.
- Outdoor wireless access points provide students Internet access in the parking lot for those who do not have Internet access at home. Students will be required to remain in their own cars to utilize the school Internet.
- Teachers and staff will receive training in delivery of distance learning and safety protocols.
- All learning is provided via a distance learning model utilizing live instructional sessions with a teacher delivered via Zoom, Google Hangouts, Google Meet or other digital platforms, recorded instructional sessions accessed and assigned through Google Classroom, workbooks and packets distributed to students, and online computer aided instructional programs including Imagine Learning, NearPod, Kahn Academy, Zearn and Brain Pop.
- Students will be allowed to pick up materials, including devices, curbside following a scheduled pick-up system.
- Staff, less than 10 at a time, will have access to the school to prepare and plan for distance learning.
- All individuals at the school will be required to remain a minimum of 6' apart and will wear masks when 6' distance is not possible.
- Custodial staff will clean and sanitize regularly.
- Lunch is provided daily using a Grab and Go curbside pick up.

## ORANGE MODERATE RISK

- School building is closed to students unless they are being provided small group or oneon-one instruction as noted below.
- Outdoor wireless access points provide students Internet access in the parking lot.

- Teachers and staff are provided training in delivery of distance learning and safety protocols. Students will need to remain in their own vehicles to access the school's Internet.
- Most learning is provided via a distance learning model utilizing live instructional sessions with a teacher delivered via Zoom, Google Hangouts, Google Meet or other digital platforms, recorded instructional sessions accessed and assigned through Google Classroom, workbooks and packets distributed to students, and online computer aided instructional programs including Imagine Learning, NearPod, Kahn Academy, Zearn and Brain Pop.
  - Teachers may provide one-on-one or small group (less than three students at a time) instruction if deemed necessary for students identified at great risk of academic failure.
  - O During any in-person instruction, all participants, including students, must wear a face mask and must remain a minimum of 6' apart.
- Students are allowed to pick up materials curbside, including devices, following a scheduled pick-up system.
- Staff are allowed in the school to prepare and plan instruction but must remain 6' apart, wear face coverings when 6' distance is not possible, and may not congregate in groups larger than 10.
- Lunch is provided daily using a Grab and Go curbside pick up.

# YELLOW LOW RISK

NOTE: The state has not provided final recommendations for YELLOW and Bridge Elementary's procedures below may change once the State provides final guidelines.

- Teachers and staff are provided training in safety protocols.
  - Temperature checks using a non-touch device are provided at the beginning of the school day.
    - Students with a temperature that exceeds the health department's minimum recommendation are isolated until they are picked up by an authorized individual.
    - Staff with a temperature that exceeds that health department's minimum recommendation are sent home.
  - Frequent hand washing and hand sanitizing is practiced.
  - High touch surfaces are wiped frequently.
  - Distancing of 6' is recommended and masks are worn by students and teachers if
    6' distancing cannot be maintained.
- Outdoor wireless access points provide students Internet access in the parking lot.
- All learning is provided via a blended learning model utilizing live face-to-face or digitally accessed instructional sessions with teacher using Zoom, Google Hangouts, Google Meet or other digital platforms, recorded instructional sessions accessed and assigned through Google Classroom, workbooks and packets distributed to students, and online

computer aided instructional programs including Imagine Learning, NearPod, Kahn Academy, Zearn and Brain Pop.

- Students are allowed in the building using a rotation schedule as to ensure less than 50% of the student population is in the school at one time.
  - Students are assigned to Group A or Group B.
    - Group A students attend school Monday and Tuesday.
    - Group B students attend school Thursday and Friday.
    - Students identified as medically high-risk attend live, digitally accessible sessions based on their assigned Group.
  - On the days in which a student is not at the school, he will complete 60 minutes of computer aided instruction and the other learning as assigned by the teacher.
  - Students attend a scheduled digital advisory session twice monthly on Wednesday with their advisor to review and update their Personalized Learning Plan (PLP).
- Lunch is provided daily.
  - Students at the school eat lunch in the lunchroom, the outdoor seating area, or their classroom following a schedule that ensures there are no more than 50 students gathered in one location.
  - Students who are not at the school can participate in Grab and Go curbside pickup based on the schedule developed by the Child Nutrition Program director.

#### **GREEN NEW NORMAL**

NOTE: The state has not provided final recommendations for GREEN and Bridge Elementary's procedures below may change once the State provides final guidelines.

- Teachers and staff are provided training in safety protocols.
  - Frequent hand washing and hand sanitizing is practiced.
  - High touch surfaces are wiped frequently.
- School resumes a traditional in-person educational program with an option for a blended or digital model for students who are physically unable to attend school.
