Applying for state reimbursements has been done and we should see some of that money start to come in, the state has been a little behind with the corona relief aid.

Rene question- Mr. Veasey do you feel you have the funds necessary to do what you need to do?

Mr. Veasey has been checking with all of the new hires and asking how they feel about the job and if they have what they need. He has gotten all positive reports from our teachers about the support we give them and the funds they have to put into their classrooms. We like to keep the funds as close as we can to the kids. Some of the lesson plans have needed to be adjusted due to COVID restrictions and some of those changes have resulted in cheaper lessons because we are limited in hands on learning activities. We want our teachers to use the funds we give them, so discussing those budgets and making sure the teachers have all that they need will be a good discussion for our board retreat.

Closed session could be needed to discuss the future of selling the land. Alan will work on how we gather the documents needed to move forward with this discussion in the January meeting. Rene proposes we get legal representation for the sale of the land.

a. COVID 19 updates

Rick our school does have a few positive cases right now. We have 2 adults and 2 students as of now. We have 4 outstanding tests currently; we are well under 15 which is the local state mandate. A lot of people are affected by quarantine. We have 70 students currently in quarantine situations. Someone on the opposing team tested positive from the basketball game last week so that effected a lot of people. Governors address today: after school activities and other activities are suspended until further notice, we are complying with state mandates now. Our biggest concern is that a change could occur when we are on break and contacting all of our kids to get that update out would be a hard task. Governor said he will make thanksgiving suggestions next week for families and hopefully for schools. Soft closure is a real concern. If the State mandates closure for middle school would we want to keep our elementary kids in school. Something to think about for next month. Emergency agenda would follow if we need to make that decision.
