STUDENT ACCEPTABLE USE POLICY

Soldier Hollow Charter School has access to the Internet. The Internet is an effective way to introduce students to the global nature of information. It allows users to share information in a variety of ways with other individuals all over the world.

The Internet has come about because groups of individuals have chosen to network their computers in order to share information globally. Some users and groups have made objectionable materials available over the Internet. Soldier Hollow Charter School takes every precaution to restrict access to objectionable material; however, an industrious student may discover it. We firmly believe that the valuable information and interaction available on the Internet outweighs the possibility that users may obtain unsuitable material. Disciplinary action will be taken against users found sending or acquiring objectionable material over the Internet. Technology protection measures are in place and used for all internet access. Monitoring of internet access usage for minors and adults is policy. The school will make every attempt to comply with Utah State Law and federal guidelines set forth in CIPA (Children's Internet Protection Act).

Soldier Hollow Charter School will provide students with training for appropriate online behavior. Training will include, but not be limited to, chat rooms, social networking sites, cyberbullying awareness, and response.

Please remember the following rules:

- Never write or share your password.
- All communication must be polite, kind, and free from inappropriate language.
- Electronic mail (e-mail) is not private.
- Your personal address & phone number should not be included in network communication (including e-mail).
- Attempts to tamper with other people's data or gain unauthorized access to accounts on the Internet are **NOT** allowed.
- Vandalism of any kind to computer equipment or software will not be tolerated.
- If you are unsure about material you have accessed on the Internet, ask your teacher or teaching assistant.

The parent/guardian shall be responsible to pay Soldier Hollow Charter School for any costs set forth in the Device Repair or Replacement Fee Schedule (below):
